O*Net, the online occupational data network, catalogs the occupations and lists related tasks as well as required knowledge, skills and abilities. The system categorizes 35 different skills into six sets ranging from basic skills, that facilitate learning or the more rapid acquisition of knowledge, to technical skills, used to design, set-up, operate and correct malfunctions involving application of machines or technical systems.

The skill categories are numbered here to match the skill categories with the projected "Primary" needs through the projected period as shown in the accompanying table. Primary skills are the first 10 skills listed for each occupation in the O*Net system. The Skills Gap Index ranks training needs as the higher the index the higher the need for proficiency in that skill.

The most recent "State of the Workforce " document that we have was published in June 2014 and provided skill analysis and projections for the 2008-2018 period. At the time the 2008-2018 projections came out, the estimate was that Region 10 would have 169,030 workers in 2018. The latest projections for the period 2012-2022, project the 2022 regional employment at 151,750. The estimated 2012 regional employment was 140,540. Regardless of the actual numbers employment level attained, the relevant skill requirements remain valid, and basic skills dominate the top of the list.
