## Dothan MSA Third Lowest In State <br> ACCRA Cost Living Index <br> Second Quarter 2014

Among the 279 urban areas that participated in the second quarter 2014 ACCRA Cost of Living Index, the Dothan area came third at $\mathbf{8 9 . 5}$ for its total index. This index represents that the overall cost of living for the Dothan area is 10.5 percent below the national average.
When compared to the other nine Alabama urban areas that participated in the 2014 second quarter Index, the Dothan area also reported the lowest in Miscellaneous Goods and Services (88.2\%).

The ACCR A Cost of Living Index measures regional differences in the cost of consumer goods and services, excluding taxes and non-consumer expenditures, for professional and managerial households in the top income quintile. It is based on more than 90,000 prices covering 60 different items for which prices are collected quarterly by chambers of commerce, economic development organizations and university applied economic centers in each participating urban area. Small differences should not be interpreted as showing a measurable difference.
The composite index is based on six component categories - Housing, Utilities, Grocery Items, Transportation, Health Care and Miscellaneous Goods and Services.
What Does Breakfast Cost? Each quarter, C2ER collects more than 90,000 prices from communities across the U.S. for the Cost of Living Index. With food prices a big part of the national media attention, C2ER decided to once again feature those communities with the most and least expensive food costs as measured by the grocery item index number. C2ER collects data on 26 items from a variety of surrogate categories to represent the grocery item component of the index. Dothan's Grocery Items index was 102.2

## The Alabama Workforce Development System

Workforce development is different than education in that workforce development programs are designed to address local and regional workforce needs while education supports individual civic, personal and professional goals.

Workforce development programs are based on needs within a geographic area, while postsecondary education supports personal preferences, which may include mobility. As workforce development is based on needs within a geographic region the thrust of the state's workforce development initiative is to support the growth of industries addressed in the state economic development plan Accelerate Alabama.

Regionally, workforce development supports the regional economic development plan. At the federal level, workforce development initiatives are supported and funded by the U.S. Department of Labor and education programs are under the purview of the U.S. Department of Education. The same type of arrangement exists at the state level, except that the Community College System has responsibility to both systems, they provide higher education programs as well as workforce development programs and adult education.

Federal workforce development funding is managed by the Alabama Department of Economic and Community Affairs, which provides administrative and fiscal support to the State and Local Workforce Investment Boards, Jefferson County, Mobile County and the balance-of-state 65 County Local Area.

The federal Workforce Investment Act provides
funding for services to adults, dislocated workers and youth clients. Training providers must be on the state approved service-provider list. The WIA system is a criteria-based system for which clients must qualify. WIA funds, as well as Wagner-Peyser funds, support the Alabama Career Center system. The Alabama Integrated Workforce Plan for the period 20122016 can be viewed at http://adeca.alabama.gov/ Divisions/wdd/Documents/2012-2016\%20 WIA\%20and\%20Wagner-Peyser\%20State\%20 Integrated\%20Workforce\%20Plan.pdf. There is an organizational diagram showing all elements of the system provided in Attachment 2 of the document.

State funding for workforce development programs are funded through the Department of Postsecondary Education Office of Workforce Development. The regional councils, of which we are Region 10, are provided the opportunity to rank regional community college responses to requests for proposals to secure funding to support regionally identified workforce training needs. The council ranks the proposals and recommends their priority for funding. State funding is not predicated on eligibility requirements and is awarded solely on need and the institutions ability to perform. Training providers are the community colleges.

In addition to the Department of Postsecondary Education, workforce development programs provided by the Community College System, Alabama Industrial Development Training within the Department of Commerce, has the resources to recruit and train individuals for specific skills for which a shortfall must be immediately addressed to support recruitment and retention efforts. A recent example of this was type of training support is the Commercial Jet Services, LLC program CJET.

## AMEA And Its Members Kick Off 2015 Scholarship Program

Will you be graduating from high school in the spring of 2015? Do you receive your electricity from a public power utility in Alabama? If your answer to these questions is "yes," you could be eligible to receive a scholarship from the Alabama Municipal Electric Authority and its 11 member cities/utilities.

Since 1992, AMEA and its members (Alexander City, Dothan, Fairhope, Foley-Riviera Utilities, LaFayette, Lanett, Luverne, Opelika, Piedmont, Sylacauga and Tuskegee) have provided scholarships to area high school seniors through the AMEA Scholarship Program. Scholarships, totaling approximately $\$ 82,500$ were awarded in the 2014 program.

Each year, AMEA and its members make available $33, \$ 2,500$ scholarships, which include regular and technical school scholarships. To be eligible for either of AMEA's scholarships, a student's family must receive electric service from a member's electric utility and the student must attend an Alabama college or university.

Applications are currently available from school counselors in these member cities, or you can go online to the AMEA website www.amea.com, Scholarship Program.

Applications are reviewed and winners are selected by an independent panel of Montgomery area college guidance personnel. Application deadline is Monday, Feb. 2, 2015.
